## RESOLUTION # 12 of 2014 Fees for Administration of the Zoning Ordinance

**WHEREAS,** Springfield Township has enacted the Springfield Township Zoning Ordinance #2 of 2001, as amended for the purposes set forth in Section 103 of the Zoning Ordinance,

**WHEREAS** the Township incurs costs in the administration of the Zoning Ordinance and,

**WHEREAS** the costs in administration of the Zoning Ordinance are directly related to the nature of the application and,

**WHEREAS** the Township has evaluated the costs incurred by the Township with respect to administration of the Zoning Ordinance including but not limited to the costs incurred by the Township with respect to permitting, conditional use hearings before the Board of Supervisors, appeals and hearings before the Zoning Hearing Board and,

**WHEREAS** the Board of Supervisors desires to amend its fee schedule with respect to administration of the Zoning Ordinance hereinafter set forth.

**Now, THEREFORE, BE IT RESOLVED** by the Springfield Township Board of Supervisors that a schedule of fees as authorized by Section 105 of the Springfield Township Zoning Ordinance to be paid to the Township for the administration and enforcement of the zoning ordinance, shall be, and is hereby established as follows:

At the time of filing of an application, the applicant shall pay a fee based on the following:

## **Building/Zoning Application and Permit Fee:**

\$25.00 for the first \$5,000 of cost of the structure, plus \$1.00 for each additional \$1,000.00 of cost, or portion thereof.

Zoning Only-\$ 25.00 (Combined with Certificate)

## Sign Application and Permit Fee:

Single Sign up to 32 square feet = \$40.00. Multiple Signs on property or signs over 32 square feet = \$50.00 plus \$2.00 per each additional square foot of signage.

Certificate of Occupancy or Certificate of Zoning: \$25.00

Temporary Use Certificate (Valid for Six Months) \$50.00

**Zoning Compliance Letter for Financing or Other Purposes** \$50.00
