

Resolution #14 of 2019

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF SPRINGFIELD
TOWNSHIP, MERCER COUNTY, PENNSYLVANIA, ADOPTING THE 2020 BUDGET
AND FIXING THE TAX RATE FOR 2020**

WHEREAS, Article XXXII, Section 3202 of the Second Class Township Code, requires the Board of Supervisors to prepare an annual budget: and

WHEREAS, in accordance with Article XXXII, Section 3202, Paragraph A of the Pennsylvania Second Class Township Code, the Board of Supervisors has conducted public budget workshops wherein the proposed 2020 budgets for all funds were reviewed and, if necessary, amended as determined by the Board; and

WHEREAS, Springfield Township has advertised the fiscal year 2020 budgets for all funds for inspection by the general public in accordance with Article XXXII, Section 3202, Paragraph B; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Springfield Township, Mercer County, Pennsylvania that the budgeted revenues and expenditures for the fiscal year 2020 shall be in accordance with the final budget document for all funds attached to and made a part of this Resolution.

BE IT FURTHER RESOLVED that the approved fiscal year 2019 budget for operation, enterprise, and capital funds shall be:

- General Fund - \$846,186 in revenue and expenditures.
- Capital Fund - \$817,532 in expenditures
- Sewer Fund - \$501,379 in revenue and expenditures
- Sewer Capital - \$95,000 in expenditures
- State Liquid Fuels - \$425,738 in revenues and expenditures
- Street Light - \$1,240 in revenue and expenditures
- Pension - \$26,517 in revenue and expenditures
- Fire Fund - \$178,861 in revenue and expenditures
- Fire Capital - \$36,000 in expenditures

BE IT FURTHER RESOLVED that a tax be and is hereby levied on all real property within Springfield Township at the rates 7.0 mills (.007) for General purposes. *The sum of \$0.70 cents on each one hundred dollars of assessed valuation.* 1 ½ mills (.0015) for Special Tax Levies Fire Tax. *The sum of \$0.15 cents of each one hundred dollar of assessed valuation.* Totaling 8.5 mills of Real Estate Tax for 2019.

BE IT FURTHER RESOLVED Local Service Tax, (LST) of \$52.00, Wage/Earned Income Tax of .5% (.05) Township and Street Lighting for Leesburg only at thirty-eight cents (\$.38) per foot for improved property and ten cents (\$.10) per foot for unimproved property.

BE IT FURTHER RESOLVED that this Resolution shall be effective on the below stated date.
